University Bank dba Midwest Loan Services may re-present my ACH that is returned NSF. I understand if either the ACH debit or credit is dishonored for any reason, I will be responsible for making my loan payment. My loan must remain current to be on a recurring ACH. If my loan becomes delinquent, my recurring ACH will be suspended until my loan is brought current again; at such time the recurring ACH will resume automatically(Accommodation payment plans will be cancelled and will require a new authorization form to be restarted). **Changes or cancellations to the debit must be made at least 5 business days prior to the next scheduled debit date by calling our Customer Service Department at (800)262-6574.**
